

Notification of the Thai Maritime Enforcement Command Center

Re: Prescription of Government Officer Identification Card Format

By virtue of Section 32 paragraph one of the National Maritime Interests Protection Act, B.E. 2562 (2019), the Director-General of the Thai Maritime Enforcement Command Center hereby issues a notification as follows:

Clause 1 The identification card of the government officers of the Thai Maritime Enforcement Command Center shall be issued in the format attached to this Notification.

Clause 2 The photograph on a government officer identification card must be taken no more than six months prior to the application date, 2.5 x 3.25 cm in size, of the upper half of the body with the applicant facing directly toward the camera, wearing a government officer uniform with no hat or dark glasses. The background must be dark blue.

Clause 3 The persons empowered to issue a government officer identification card are:

3.1 The Secretary-General of the Thai Maritime Enforcement Command Center shall be the issuer of identification cards for government officers of the Thai Maritime Enforcement Command Center;

3.2 The director of the Area Thai Maritime Enforcement Command Center shall be the issuer of identification cards for government officers of the Area Thai Maritime Enforcement Command Center.

Clause 4 Government officer identification cards shall be valid for the period of time specified on the card, but must not exceeding five years from its date of issue.

Clause 5 In the event that a person, who has been appointed a government officer of the Thai Maritime Enforcement Command Center, is no longer a government officer of the Center after having left the position or the affiliated agency, such person shall return his or her identification card to the issuing agency.
